With reference to the subject cited above, like previous year the Principal of all the Jawahar Navodaya Vidyalayas are authorized for preparation of panels through walk-in interview (except FCSA) for the Academic Session 2019-20 for PGTs, Misc. Category teachers & Female Staff Nurse to be engaged on contract basis against the available vacancies. The whole process is to be completed at Vidyalaya Level. ***However, the TGTs are being provided from the panel of Regional Office.*** The dates fixed for walk in interview are given here under:-

NOTE for FCSA : Applications are to be submitted on email fcsanvsjpr2019@gmail.com only and no offline applications will be entertained either by JNVs or RO. The detailed guidelines, eligibility criteria and applications forms is available in the website www.nvsrojpr.gov.in. The selected candidates will be paid a fixed monthly remuneration of Rs. 26250/- per month for the period of contract. Application alongwith all the relevant documents should be sent on the Email ID: fcsanvsjpr2019@gmail.com up to 14.06.2019 by 24.00 hrs. **No walk in interview will be conducted for FCSA.**

1. Each Jawahar Navodaya Vidyalaya will upload actual vacancy position of teachers/female staff nurse and Matron on their website alongwith the advertisement as suggested by Regional Office, Jaipur. The Regional Office has already published the advertisement in Newspapers (Copy enclosed as **Annexure- A**). The same is also available on the website of Regional Office. The Principals are advised to give it wide publicity through publishing a news in the Local News papers with the help of district administration.
2. The eligibility criteria for different cadres are also enclosed as Annexure-B.
3. The guidelines for preparation of the Merit List is enclosed separately as Annexure '**C**' to '**J**'.
4. It shall be the responsibility of the Principal to see that all arrangements for the Walk-In-Interview are properly made and the required activities as per the time schedule are ensured in order to avoid any inconvenience during the interview. Further, Principal of the concerned JNV shall keep/maintain all the required relevant records viz. applications of candidates along with documents in support of qualifications, Panels, list of candidates attended etc. pertaining to interview for all future correspondences.
5. Once the Vidyalaya completes the offer of appointment against the vacancies published, the remaining panels prepared in JNVs will be kept for their further use during the academic session 2019-20 and the panel (finalized) should also be made available on the website of Vidyalaya to maintain the transparency in recruitment of JNV.

The Subject Experts and other members called from outside the Samiti, will be paid an honorarium @ Rs.1500/- per day (inclusive of conveyance allowance). **Please, ensure that the Subject Experts are identified and their consent is obtained well in time so that they are available on the date and time as indicated above.**

The principal shall be responsible to conduct the Interview in a very smooth and safe manner under his supervision. He should also ensure that recruitment is made strictly as per prescribed norms and procedure. The arrangement of conveyance will also be arranged by the venue JNV on day-to-day requirement basis by following prescribed procedure and usual norms of the Samiti.
